Criteria for beginning this report are based on the season's last significant rainfall event where the soil moisture profile is estimated to be near its highest level for the new season. * Estimates are for orchard/vineyard floor conditions where vegetation is managed by some combination of strip applications of herbicides, frequent mowing or tillage, and by mid and late season shading. Weekly estimates of soil moisture loss can be as much as 25 percent higher in orchards where cover crops are planted and managed more intensively for maximum growth.
